Nothing contained in this Assignment is intended to modify any of the provisions of the Asset Purchase Agreement as they relate to the Trademarks, including any of the representations, warranties, covenants or indemnities set forth in the Asset Purchase Agreement. In the event of any conflict between this Assignment and the Asset Purchase Agreement, the Asset Purchase Agreement shall control.


