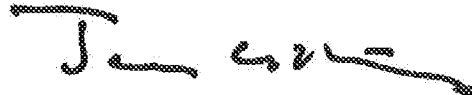

TWO

"The name of the Corporation is Bright View Technologies Corporation."

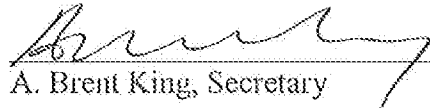
THREE
