Pursuant to Title 8, Section 252 of the General Corporation Law of the State of Delaware (the "DGCL"), the undersigned DOES HEREBY CERTIFY THAT:

FIRST: The names of the constituent corporations that are to merge are VC3, Inc., a South Carolina corporation ("VC3-South Carolina"), and VC3, Inc., a Delaware corporation ("VC3-Delaware").

SECOND: An Agreement and Plan of Merger, dated February 16, 2016, by and among VC3-South Carolina and VC3-Delaware (the "Merger Agreement"), has been approved, adopted, certified, executed and acknowledged by each of the aforesaid constituent corporations in accordance with Title 8 Section 252 of the General Corporation Law of the State of Delaware.

THIRD: Under the terms of the Merger Agreement, VC3-South Carolina will merge with and into VC3-Delaware. The name of the surviving corporation is VC3, Inc., a Delaware corporation (the "Surviving Corporation").

FOURTH: Upon the effectiveness of the merger provided for hereby, the certificate of incorporation of the Surviving Corporation shall be its certificate of incorporation.

FIFTH: The Merger shall be effective as of the filing of this Certificate with the Secretary of State of Delaware and said time shall be the effective merger time.

SIXTH: The executed Merger Agreement between the aforesaid constituent corporations is on file at an office of the Surviving Corporation at the following address: 1301 Gervais St., Suite 1800, Columbia, SC 29201.


SEVENTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of either of the constituent corporations.

EIGHTH: The authorized stock and par value of VC3-South Carolina is 5,000,000 shares, no par value per share.
