SECTION 14-2-1109.3 OF THE GEORGIA LIMITED LIABILITY COMPANY ACT**

1. The name of the Corporation is Americo Manufacturing Co., Inc.

The Corporation irrevocably appoints the Secretary of State of the State of Georgia as the agent for service of process on Americo Manufacturing Co., LLC in any proceeding to enforce an obligation of the Corporation arising prior to the effective date of the conversion.

7. The Secretary of State of the State of Georgia shall be notified of any change in the mailing address of Americo Manufacturing Co., LLC.
