TO HAVE AND TO HOLD the aforementioned properties, assets and rights unto Assignee, its affiliates, successors, and assigns, to and for its use forever.

Assignor shall promptly, upon the request of Assignee and/or its affiliates, successors, and assigns, execute such other documents and/or instruments of assignment, transfer and conveyance as Assignee and/or its successors and assigns may reasonably request to permit the recordation of the assignment made by this instrument or of any other documents Assignee or any of its affiliates, successors, or assigns may reasonably deem necessary or advisable to evidence or effectuate the terms and intent of this Assignment. Without limiting the foregoing, Assignor hereby irrevocably appoints Assignee and each of Assignee’s officers and/or directors, affiliates, successors, and assigns, signing singly as attorney-in-fact with full power (and coupled with an interest), with full power of substitution, to be Assignor’s true and lawful attorney, in Assignor’s name, place and stead, to execute, acknowledge, swear to and file all documents (including but not limited to any instrument of assignment, transfer and/or conveyance) and to take all actions which Assignor or such other person deems necessary, appropriate or desirable to evidence or effectuate the intent of this Assignment.

This Assignment shall be binding upon the parties and their successors and assigns. This Assignment may be executed in counterparts, each of which shall be deemed an original and all of which, when taken together, shall constitute one and the same instrument. 


