## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this “Release”) is effective as of May 31, 2018, by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent (in such capacity, “Secured Party”).

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of May 4, 2017, by EMS SOFTWARE, LLC, a Delaware limited liability company (the “Grantor”) in favor of Secured Party (the “Security Agreement”), the Grantor granted to Secured Party a continuing security interest in and continuing lien upon all of the Trademark Collateral (as defined in the Security Agreement) of the Grantor, including, without limitation, the trademarks and licenses listed on Exhibit A hereto (collectively, the “Trademarks”); and

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on May 18, 2017 at Reel/Frame 6058/0190.

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreement, Secured Party hereby (i) releases the continuing security interest and continuing lien upon, and terminates its security interest in, and all other rights, title and interest in and to, the Trademarks, without any recourse, representation or warranty, (ii) terminates the Security Agreement, and (iii) re-assigns to the Grantor, any right, title or interest the Secured Party may have in, to or under the Trademarks, together with the goodwill of the business symbolized thereby, and hereby authorizes the Grantor or the Grantor’s authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination. Secured Party further agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release.
