

The Administrative Agent hereby terminates, discharges, and releases the continuing security interest in, and the right to set off against, any and all right, title and interest of Obligor in and to the Trademark Collateral, including the Trademarks set forth on Schedule A attached hereto, granted pursuant to the Security Agreement.




