ACKNOWLEDGMENT OF SECURITY INTEREST IN TRADEMARKS

THIS ACKNOWLEDGMENT OF SECURITY INTEREST IN TRADEMARKS (the "Agreement") is made as of May 2, 2018, by Safety Systems and Signs Hawaii, Inc., a Delaware corporation ("SSS Hawaii"), and Statewide Traffic Safety and Signs, Inc., a Delaware corporation ("Statewide" and together with SSS Hawaii and each Person joined hereto as a Grantor from time to time, collectively, the "Grantors" and each a "Grantor"), in favor of PNC BANK, NATIONAL ASSOCIATION, as agent (in such capacity, "Agent") for the Lenders (as defined below).

W I T N E S S E T H

WHEREAS, Grantors, certain of their affiliates and subsidiaries, Agent, and the lenders from time to time party thereto ("Lenders") have entered into a certain Revolving Credit, Term Loan and Security Agreement, dated as of the date hereof (as the same may be amended, modified, supplemented, renewed, restated or replaced from time to time, the "Credit Agreement"), providing for extensions of credit to be made to the Borrowers thereunder by Agent and Lenders; and

WHEREAS, pursuant to the terms of the Credit Agreement, each Grantor has granted to Agent, for itself and the ratable benefit of the Secured Parties, a Lien upon substantially all of the assets of such Grantor;

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

1. Grant and Reaffirmation of Grant of Security Interests. To secure the complete and timely payment and satisfaction of the Obligations, each Grantor hereby reaffirms its prior grant to Agent pursuant to the Credit Agreement of a continuing security interest in such Grantor's entire right, title and interest in and to the following, whether now owned or existing or hereafter created or acquired (collectively, the "Trademark Collateral"): (a) each trademark, trademark application and/or trademark registration listed on Schedule 1 annexed hereto, together with any renewals thereof, and all of the goodwill of the business connected with the use of, and symbolized by, such trademark, trademark application and/or trademark registration; and (b) all products and proceeds of the foregoing, including without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any trademark, trademark application and/or trademark registration, or (ii) injury to the goodwill associated with any trademark, trademark application and/or trademark registration.

2. Credit Agreement. The security interests referred to in this Agreement were granted to Agent, on behalf of itself and Lenders, pursuant to the Credit Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the Trademark Collateral are more fully set forth in the Credit Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. All terms capitalized but not otherwise defined herein shall have the same meanings herein as in the Credit Agreement.

3. Governing Law. This Agreement shall be governed by, construed and enforced in accordance with the internal laws of the State of New York.

4. Counterparts; Electronic Signatures. This Agreement may be executed in any number of and by different parties hereto on separate counterparts, all of which, when so executed, shall be deemed an original, but all such counterparts shall constitute one and the same agreement. Any


signature delivered by a party by facsimile or electronic transmission (including email transmission of a .pdf image) shall be deemed to be an original signature hereto.
