Trademark 1102618 Assignment and License Back Agreement

This Trademark Assignment and License Back Agreement (the "Agreement") is made as of June 4, 2018 (the "Effective Date"), between OPTRONICS INTERNATIONAL, LLC. (the "Assignor"), and VerandaGlobal.com, Inc., DBA First Place Internet, Inc. (the "Assignee").

The Assignor is the registered owner of a mark that is registered in the United States Patent and Trademark Office, Registration No. 1102618, registration date September 19, 1978 (Exhibit A).

The Assignee paid the Assignor good and valuable consideration on 5/31/18, and the Assignee acquired the Assignor's rights in the trademark listed in this agreement.

In exchange, the Assignor conveys, transfers, and assigns to the Assignee all of the Assignor's right, title, and interest of whatever kind in the mark, together with the goodwill relating to the products on which the mark is used and for which it is registered.

The Assignor attests the mark as set forth in the registration is in active use for a wide variety of lighting products, and the Assignee licenses back to the Assignor, full use of the mark listed in this agreement, for six years, terminating June 4th, 2024. Assignor's licensed use of the trademark will maintain quality and consistency of the products and/or services sold under the trademark during the licensed period.

Notwithstanding the foregoing, Assignee acknowledges that Assignor utilizes the design element of the trademark within its Optronics logo as set forth on Exhibit B, Assignee does not object and will not object to the use thereof, and nothing herein shall transfer any of Assignor's rights to its Optronics logo.
