AMENDMENT TO ASSIGNMENT AND RELEASE OF SECURITY INTEREST

This AMENDMENT TO ASSIGNMENT AND RELEASE OF SECURITY INTEREST (this "Amendment") is made as of June 14, 2018. Reference is hereby made to that certain Assignment and Release of Security Interest dated as of April 1, 2015 (the "Release"), which was executed by Société Générale, in its capacity as collateral agent (in such capacity, the "Collateral Agent"). The Release was executed with respect to collateral assigned to the Collateral Agent pursuant to that certain Intellectual Property Security Agreement dated as of June 20, 2012 by MegaPath Group, Inc., a Delaware corporation, and MegaPath Corporation, a Virginia corporation, in favor of the Collateral Agent (the "Security Agreement").

Whereas one of the trademarks assigned to the Collateral Agent pursuant to the Security Agreement was inadvertently omitted from Schedule A to the Release.

Now, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby amends Schedule A to the Release to add the following trademark to such Schedule A:
