**TERMINATION AND RELEASE OF
SECURITY INTEREST IN
TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of June 12, 2018, is made by CRYSTAL FINANCIAL LLC, in its capacity as agent (in such capacity, the "Agent") for the Lenders under the Term Loan Agreement (each as defined below).

WITNESSETH:

WHEREAS, reference is made to that certain Term Loan Agreement dated as of April 24, 2015 (as amended, restated, supplemented or otherwise modified from time to time, including all schedules thereto, the "Term Loan Agreement"), among TRI VENTURES, INC., a Massachusetts corporation ("Parent"), AQUENT LLC, a Delaware limited liability company ("Aquent"), TRI INVESTMENTS, LLC, a Delaware limited liability company ("TRI Investments"), and together with Aquent, individually and collectively, "Borrower"), each of Parent's Subsidiaries (other than Borrower) signatory thereto (such Subsidiaries, together with Parent, each a "Guarantor" and collectively, the "Guarantors"), the lenders party thereto as "Lenders" (such Lenders, together with their respective successors and assigns, each a "Lender" and collectively, the "Lenders"), and Agent;

WHEREAS, pursuant to the Trademark Security Agreement dated as of April 24, 2015 (the "Original Trademark Security Agreement") as amended by Amendment No. 1 to Trademark Security Agreement dated as of July 20, 2016 (the "First Amendment"), and the Original Trademark Security Agreement as so amended, the "Trademark Security Agreement"), a lien on and security interest (the "Security Interest") was granted by Aquent, LiTL LLC, SCOUT EXCHANGE LLC, and TALENT DRIVE LLC (collectively, the "Grantors") to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Original Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on April 24, 2015, at Reel/Frame 5503/0659 and at Reel/Frame 5504/0112, and the First Amendment was recorded on July 21, 2016, at Reel/Frame 5839/0262; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantors' rights, titles and interests of every kind and nature in, to and under the Trademarks listed on Schedule 1 hereto. Capitalized terms not defined herein have the meanings set forth in the Trademark Security Agreement.


2. Release of Security Interest. The Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Trademark Collateral listed on Schedule 1 hereto, and any right, title or interest of the Agent in such Trademark Collateral listed on Schedule 1 hereto shall hereby cease and become void.

3. Recordation. The Agent authorizes the United States Commissioner for Trademarks or any other applicable government officer to record this Termination and Release at the Grantors' expense.
