RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (“**Release**”) is made and effective as of June 14, 2018 and granted by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as agent for the Secured Parties (in such capacity, the “**Agent**”), in favor of Intertape Polymer Corp. (“**Intertape**”), IPG (US) Holdings Inc. (“**IPG (US) Holdings**”), IPG (US) Inc. (“**IPG (US)**”), Intertape Polymer Group Inc. (the “**Company**”), Intertape Polymer Inc. (“**Intertape Polymer Canada**”), Spuntech Fabrics Inc., Intertape Polymer US Inc. and IPG Luxembourg Finance S.à r.l. (collectively, the “**Initial Grantors**”) and Better Packages, Inc. and RJM Manufacturing, LLC (formerly, RJM Manufacturing, Inc.) (collectively, the “**Additional Grantors**” and, together with the Initial Grantors, collectively, the “**Grantors**”) and their successors, assigns and legal representatives.

WHEREAS, pursuant to that certain Credit Agreement, dated as of November 18, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”) among Intertape, IPG (US) Holdings, IPG (US), the Company and Intertape Polymer Canada, as borrowers, the Subsidiary Guarantors party thereto, the banks and financial institutions from time to time party thereto as lenders and the Agent, as Administrative Agent, the Grantors executed and delivered to the Agent (i) that certain Guaranty and Security Agreement by and among the Initial Grantors, the other grantors identified therein or joined thereto from time to time and the Agent, dated as of November 18, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Guaranty and Security Agreement**”), (ii) that certain Trademark Security Agreement by and among the Initial Grantors and the Agent dated as of November 18, 2014 (the “**Initial Trademark Security Agreement**”), and (iii) that certain Trademark Security Agreement by and among the Additional Grantors and the Agent, dated as of August 23, 2016 (the “**Additional Trademark Security Agreement**”; together with the Guaranty and Security Agreement and the Initial Trademark Security Agreement, the “**Security Agreements**”; all initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreements or, if not defined therein, in the Credit Agreement);

WHEREAS, pursuant to the Security Agreements, each Grantor pledged and granted to the Agent for the ratable benefit of the Secured Parties a security interest in and to all of the right, title and interest of such Grantor in, to and under the Trademark Collateral (as defined below);

WHEREAS, the Initial Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 005406, Frame 0425 on November 22, 2014;

WHEREAS, the Additional Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5863, Frame 0208 on August 24, 2016; and

WHEREAS, the Grantors have requested that the Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantors of any and all right, title and interest the Agent and the Secured Parties may have in the Trademark Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby states as follows:

1. Release of Security Interest. Agent, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby terminates each of the Initial Trademark Security Agreement and the Additional Trademark Security Agreement and


terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreements in any and all right, title and interest of the Grantors, and reassigns to each Grantor any and all right, title and interest that it may have, in, to and under the following (collectively, the “**Trademark Collateral**”):

- a. all of such Grantor’s Trademarks including those referred to on Schedule 1;
 - b. all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Intellectual Property License with respect to Trademarks; and
 - c. all products and proceeds (as that term is defined in the Code) of the foregoing, including any (i) claim by such Grantor against third parties for past, present or future infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.
2. Further Assurances. Agent agrees, at the Grantors’ expense, to take all further actions, and provide to the Grantors and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantors and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
3. GOVERNING LAW, SUBMISSION TO JURISDICTION AND SERVICE OF PROCESS, WAIVER OF JURY TRIAL AND VENUE PROVISION. THIS RELEASE SHALL BE SUBJECT TO THE PROVISIONS REGARDING GOVERNING LAW, SUBMISSION TO JURISDICTION AND SERVICE OF PROCESS, WAIVER OF JURY TRIAL AND VENUE SET FORTH IN SECTION 25 OF THE GUARANTY AND SECURITY AGREEMENT, AND SUCH PROVISIONS ARE INCORPORATED HEREIN BY THIS REFERENCE, MUTATIS MUTANDIS.


