**RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF
TRADEMARKS AND TRADEMARK APPLICATIONS**

Reference is hereby made to that certain Trademark Security Agreement, dated as of July 31, 2017 (the "Agreement"), executed by CTUIT Inc., a California corporation (the "Corporation") whose address is 12303 Technology Blvd., Suite 930D, Austin, Texas 78727 in favor of Deerpath Funding, LP, a Delaware limited partnership ("Agent") whose address is 405 Lexington Avenue, 53rd Floor, New York, NY 10174, which was recorded in the United States Patent and Trademark Office on July 31, 2017 at Reel 006118, Frame 0331, pursuant to which the Corporation assigned and granted to the Agent a security interest in and to all of the Corporation's right, title and interest in and to certain trademarks and trademark applications, including those trademarks and trademark applications specifically listed on Exhibit A attached hereto and the goodwill associated therewith (collectively, the "Marks");

WHEREAS, the Obligations (as defined in the Agreement) have been paid in full and Agent wishes to terminate the Agreement, release said security interest in and to the Marks, and retransfer and reassign to the Corporation, without representation or warranty, all of Agent's right, title and interest in and to the Marks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby terminates the Agreement, releases said security interest in and to the Marks, and retransfers and reassigns to the Corporation, without representation or warranty, all of Agent's right, title and interest in and to the Marks and the goodwill associated therewith.
