**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of March 23, 2018 is made by **ROYAL BANK OF CANADA**, as Agent (defined below) in favor of the Pledgors listed on Schedule I hereto.

WITNESSETH

WHEREAS, in connection with that certain First Lien Security Agreement dated as of November 25, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), by and among Omnitracs Holdings, LLC, a Delaware limited liability company (f/k/a Coronado Guarantor, LLC, “**Holdings**”), Omnitracs Midco, LLC, a Delaware limited liability company (f/k/a Coronado Holdings, LLC, the “**Initial Borrower**”), Omnitracs, LLC, a Delaware limited liability company (f/k/a Omnitracs, Inc., “**Omni**” and together with the Initial Borrower, the “**Borrowers**” and each a “**Borrower**”), the subsidiary guarantors from time to time party thereto (together with Holdings, the “**Guarantors**”), as pledgors, assignors and debtors (Borrowers, together with the Guarantors, in such capacities and together with any successors in such capacities, the “**Pledgors**,” and each, a “**Pledgor**”), the Lenders party thereto (the “**Lenders**”) and Royal Bank of Canada, as Administrative Agent and Collateral Agent (in such capacities, the “**Agent**”), the Lenders severally agreed to make extensions of credit to the Borrower;

WHEREAS, pursuant to the Security Agreement, Pledgor was required to execute and deliver (i) that certain First Lien Trademark Security Agreement, dated as of November 23, 2013, as supplemented by that certain First Lien Trademark Supplement, dated as of December 19, 2013, and as further supplemented by that certain First Lien Trademark Supplement, dated as of October 31, 2014 (as amended, restated, further supplemented or otherwise modified from time to time, the “**Trademark Security Agreement**”), (ii) that certain First Lien Patent Security Agreement, dated as of November 23, 2013, as supplemented by that certain First Lien Patent Supplement, each dated as of December 19, 2013 and as further supplemented by that certain First Lien Patent Supplement, dated as of October 31, 2014 (as amended, restated, further supplemented or otherwise modified from time to time, the “**Patent Security Agreement**”) and (iii) that certain and First Lien Copyright Security Agreement, dated November 25, 2013 (the “**Copyright Security Agreement**” and, together with the Trademark Security Agreement and the Patent Security Agreement, the “**IP Security Agreements**”). All capitalized terms used herein but not otherwise defined herein shall have the meanings assigned thereto in the Trademark Security Agreement, the Patent Security Agreement and the Copyright Security Agreement, as applicable;

WHEREAS, pursuant to the IP Security Agreements, the Pledgors granted continuing security interests in the Trademark Collateral, the Patent Collateral and the Copyright Collateral, as applicable, including without limitation the intellectual property as listed on Schedule I attached hereto (the “**Intellectual Property Collateral**”);

WHEREAS, the Trademark Security Agreement and each supplement thereto was recorded in the United States Patent and Trademark Office (the “**USPTO**”) on the date and in the reel and frame numbers as set forth on Annex I hereto;

WHEREAS, the Patent Security Agreement and each supplement thereto was recorded in the USPTO on the date and in the reel and frame numbers as set forth on Annex II hereto;

WHEREAS, the Copyright Security Agreement was recorded in the United States Copyright Office (the “**Copyright Office**”) on the date and in the volume and document number as set forth on Annex III hereto; and

NOW THEREFORE, Agent hereby irrevocably (i) releases, without representation, recourse or warranty whatsoever, all of its security interest in all Intellectual Property owned by the Pledgors including Intellectual Property Collateral, whether granted pursuant to any agreement or document delivered in connection with the Security Agreement, and Agent hereby reassigns any and all such right, title and interest (if any) that Agent may have in the Intellectual Property Collateral to the Pledgor and (ii) terminates the Trademark Security Agreement, the Patent Security Agreement and the Copyright Security Agreement.

The Agent hereby authorizes that this Release may be recorded by or for the Pledgor (or its designees), at the Pledgor’s expense, with the U.S. Patent and Trademark Office, the United States Copyright Office or any similar office or agency within or outside the United States.

The Agent agrees, at Pledgor's sole cost and expense, to cooperate with Pledgor and to provide Pledgor with the information, additional authorization and assistance (including, without limitation, the execution and delivery of any documents or other instruments) reasonably required to effect the release of the Agent’s security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


