**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

June 15, 2018

This Release of Security Interest in Trademarks (“Release”) is made as of June 15, 2018, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (the “Administrative Agent”), a United States national banking association whose address is 201 South College Street, 8th Floor, Charlotte, North Carolina 28288-0680, in favor of CARDPOOL, INC. (“Cardpool”), a Delaware corporation with an address at 6220 Stoneridge Mall Road, Pleasanton, California 94588 (the “Grantor”).

WHEREAS, the Grantor entered into a certain Collateral Agreement dated as of March 28, 2014, with the Administrative Agent for the benefit of the Secured Parties referenced therein (as the same may have been amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”; capitalized terms used but not otherwise defined herein have the meanings given to them in the Collateral Agreement.).

WHEREAS, pursuant to the Collateral Agreement, the Grantor entered into a Trademark Security Agreement dated as of March 28, 2014, notice of which was recorded on April 24, 2014 at the United States Patent and Trademark Office at Reel 5267, Frame 0825 (the “Trademark Security Agreement”).

WHEREAS, the Grantor granted the Administrative Agent, under the terms of the Collateral Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to its Collateral, including the trademarks listed in Schedule A.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all Collateral, including such trademark as herein provided.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, does hereby unconditionally and expressly release, terminate and forever discharge and extinguish any and all of its right, title and interest in and to any and all liens and security interests it may have in the Collateral of the Grantor, including the trademarks listed in Schedule A, and hereby retransfers and reassigns to Grantor the Security Interest and all of the Administrative Agent’s right, title and interest in, to and under the Released Collateral and terminates the Trademark Security Agreement. The Administrative Agent will take all such further actions, execute and deliver, at the request and cost of Grantor such further instruments, documents and release forms as Grantor may reasonably request or are required to more effectively release, terminate, discharge, and extinguish any such liens and security interests upon such Released Collateral.

This Release shall be binding upon the Administrative Agent, its legal representatives, assigns and successors. The Administrative Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
