**TRADEMARK SECURITY AGREEMENT**

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of April 4, 2018 is executed by **PTG (assignment for the benefit of creditors), LLC**, a Delaware limited liability company ("Grantor") for the benefit of **BOSS HOLDINGS, INC.**, a Delaware corporation, as administrative agent for the Lender, (the "Administrative Agent"), in connection with a Secured Promissory Note dated as of April 2, 2018, among the Grantor and the other borrowers party thereto, Administrative Agent, and the lender party thereto (the "Lender") (as amended, restated, supplemented or otherwise modified from time to time, the "Secured Promissory Note"). Capitalized terms not otherwise defined in this Agreement are being used in this Agreement as defined in the Secured Promissory Note.

Pursuant to the Secured Promissory Note, Grantor has granted to Administrative Agent, for the benefit of the Lender, a security interest in substantially all of its assets, including all of its right, title, and interest in, to, and under all now owned and hereafter acquired trademarks, trademark applications, trademark licenses, and all products and proceeds thereof, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the obligations under the Secured Promissory Note. Pursuant to the Secured Promissory Note, Grantor is required to execute and deliver this Agreement to Administrative Agent for benefit of the Lender.

In consideration of the mutual agreements set forth herein and in the Secured Promissory Note, Grantor does hereby grant to Administrative Agent for the benefit of the Lender and, a continuing security interest in all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired:

- (1) each Trademark and Trademark application, including, without limitation, each Trademark and Trademark application referred to in Schedule 1, together with any renewals or divisionals thereof and all goodwill associated therewith (though excluding any "intent to use" Trademark application for which a statement of use has not been filed and accepted with the United States Patent and Trademark Office); and
- (2) all products and Proceeds of the foregoing, including, without limitation, any royalties or any claim by Grantor against third parties for past, present or future infringement of any Trademark, including, without limitation, any Trademark referred to in Schedule 1 and any Trademark issued pursuant to a Trademark application referred to in Schedule 1 (items (1) and (2) being herein collectively referred to as the "Trademark Collateral").

This security interest is granted in conjunction with the security interests granted to Administrative Agent pursuant to the Secured Promissory Note and subject to limitations set forth therein. Grantor hereby acknowledges and affirms that the rights and remedies of Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Secured Promissory Note, the terms and provisions of each of which are incorporated by reference herein as if fully set forth herein.

As used in this Agreement, the capitalized terms "Proceeds" and "Trademarks" are defined as follows:

"Proceeds" means all "proceeds" as such term is defined in Section 9 102(a)(64) of the Uniform Commercial Code as in effect on the date hereof and from time to time in the State of Delaware.

"Trademarks" means (a) all trademarks, trade names, corporate names, Grantor's names, business names, fictitious business names, trade styles, service marks, logos, and other source or business identifiers, and all goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith (other than any "intent-to-use" applications), whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto; and (b) the right to obtain all renewals thereof.




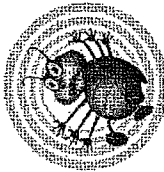
