ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS ("Assignment"), dated February 14, 2018, is entered into by C. R. Bard, Inc. ("Assignor") and Merit Medical Systems, Inc. ("Assignee").

## RECITALS:

WHEREAS, Assignor is the owner of those certain marks, and the registrations and applications and any common law rights in the marks, listed on Schedule A attached hereto and made a part hereof (the "Trademarks") and the domain name registrations listed on Schedule B attached hereto and made a part hereof (the "Domain Name Registrations");

WHEREAS, pursuant to the Asset Purchase Agreement dated as of November 15, 2017 (the "Agreement"), by and between Assignor and Assignee, Assignor desires to sell, transfer, convey, assign and deliver to Assignee, and Assignee desires to acquire, all of Assignor's right, title and interest in, to and under the Trademarks, all of the goodwill associated with the Trademarks, and all registrations and applications for registration thereof and common law rights therein, and the Domain Name Registrations.

NOW, THEREFORE, for good and valuable consideration provided in connection with the sale and purchase of assets pursuant to the Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby conveys, assigns, transfers and delivers to Assignee, its successors and assigns, its entire right, title and interest throughout the world in, to, and under: (i) the Trademarks, along with (a) all rights to sue or recover and retain damages, costs and attorneys' fees for past, present and future infringement, misappropriation or other violation thereof (including, without limitation, all income, royalties, damages, and payments hereafter due or payable to Assignor with respect to any Trademark or Domain Name Registration); (b) all material unregistered trademarks, together with all adaptations, derivations and combinations thereof; and (c) all goodwill associated with any of the foregoing throughout the world; and (ii) the Domain Name Registrations.

Section 1. Assignor hereby authorizes and requests the Commissioner for Trademarks (and, with respect to any equivalent foreign rights, any other appropriate foreign or international office or registrar) to record Assignee as owner of the registered Trademarks and to issue any and all Trademarks to Assignee, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.

Section 2. Assignor agrees to take, at Assignee's expense for reasonable out-of-pocket costs, such further action, execute such additional documents, provide testimony, and, in general, provide all lawful cooperation reasonably requested by Assignee to perfect Assignee's title in, to and under the Trademarks to fully accomplish the transfer of the Domain Name Registrations from Assignor to Assignee, and to carry out and fulfill the purposes and intent of this Assignment of Trademarks.

Section 3. The rights and obligations of Assignor and Assignee shall be governed by, and this Assignment shall be interpreted, construed and enforced in accordance with, the laws of the State of Delaware, excluding its conflict of laws rules to the extent such rules would apply the law of another jurisdiction.


Section 4. This Assignment may be signed in any number of counterparts, including facsimile copies thereof or electronic scan copies thereof delivered by electronic mail, each of which shall be deemed an original, with the same effect as if the signatures thereto and hereto were upon the same instrument.

Section 5. The parties hereto acknowledge and agree that nothing in this Assignment shall be deemed to supersede, enlarge, modify or waive any of the provisions of the Agreement, all of which shall survive the execution and delivery of this Assignment as provided in, and subject to the limitations set forth in, the Agreement. If any conflict exists between the terms of this Assignment and the terms of the Agreement, the terms of the Agreement shall govern and control.

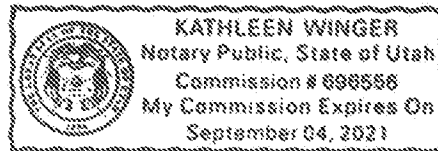
