WHEREAS, Harris Corporation, a Delaware corporation, whose business address is 1025 West NASA Boulevard, Melbourne, Florida 32919 (hereinafter "Assignor"), was as of the Effective Date set forth below, the owner of all right, title and interest in and to the service marks and trademarks (collectively the "Marks") and the registrations thereof (the "Registrations"), which are listed in Schedule A attached hereto, together with and including all goodwill of the business symbolized by the Marks; and

WHEREAS, Exelis Visual Information Solutions, Inc., a Colorado corporation, whose business address is 385 Interlocken Crescent, Suite 300, Broomfield, Colorado 80021 ("Assignee"), is desirous of acquiring, and has acquired from Assignor as of the Effective Date, all worldwide right, title and interest in, to and under the Marks, the Applications, the Registrations and all goodwill of the business symbolized by the Marks.

NOW, THEREFORE, in consideration of the sum of One U.S. Dollar (\$1.00) and other good and valuable consideration, the receipt, sufficiency and reasonably equivalent value of which are hereby mutually acknowledged, Assignor does hereby irrevocably sell, assign, transfer and convey unto Assignee, its successors and assigns, *nunc pro tunc* effective as of January 1, 2016 (the "Effective Date"), all worldwide right, title and interest in, to and under: (a) the Marks, (b) the Registrations, (c) any and all common law rights held by Assignor in, to and under the Marks, (d) all goodwill of the business symbolized by the Marks, (e) any and all rights to royalties, profits, compensations, license fees or other payments or remuneration of any kind relating to the Marks and/or the goodwill under the Marks, and (f) any and all claims, choses in action, and/or causes of action which Assignor had or has as of the Effective Date or may have at any time, in connection with the Marks, the Registrations and/or goodwill of the business

symbolized by any or all the Marks, including but not limited to, the right to sue and recover damages for any and all past infringements of the Marks and/or the Registrations; all of the foregoing to be held and enjoyed by Assignee, its successors and assigns as fully and entirely as same would have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

This instrument and any and all proceedings commenced in connection with or relating to this instrument, shall be governed by, and construed and enforced in accordance with, the laws of the State of Florida without regard of the laws that might otherwise govern under applicable principles of conflict of laws.

This instrument, and the sale, assignment, transfer and conveyance made hereunder, are effective commencing as of the Effective Date.

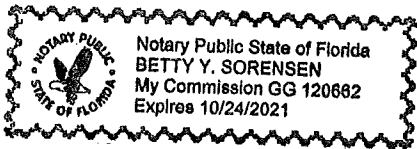
