WHEREAS, Assignor is the owner of the trademark "WORKPOINT", Registration Number 1,874,554 (the "Trademark"), and


WHEREAS, Assignee is desirous of acquiring the entire right, title and interest in and to the Trademark.

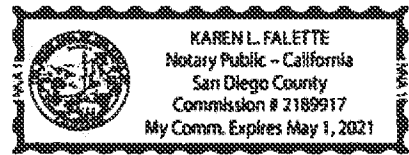
