**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "Release") is made as of June 18, 2018 ("Effective Date"), by REGIONS BANK, in its capacity as administrative agent and collateral agent for the Lenders and the LC Issuer (in such capacity, the "Administrative Agent"), in favor of VERSATEX BUILDING PRODUCTS, LLC, a Pennsylvania limited liability company (the "Grantor"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Credit Agreement (as defined below).

**W I T N E S S E T H:**

**WHEREAS**, Administrative Agent is a party to that certain Credit and Security Agreement dated as of September 28, 2016, as amended by that certain First Amendment to Credit and Security Agreement dated as of September 26, 2017 (as so amended and as the same may be further amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement") by and among Grantor, Versatex Holdings, LLC, the financial institutions from time to time party thereto (the "Lenders"), and Administrative Agent; and

**WHEREAS**, pursuant to the Credit Agreement, Grantor granted to Administrative Agent a security interest in those certain trademarks set forth on Schedule 1 hereto (the "Trademark Collateral"); and

**WHEREAS**, Grantor has requested a release of the security interest granted and recorded against the Trademark Collateral.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby (i) releases, terminates, discharges and cancels and re-assigns to Grantor any and all liens, security interests, right, title and interest Administrative Agent may have in, to and under the Trademark Collateral, together with all the goodwill associated therewith; (ii) agrees that it shall, at the sole cost and expense of Grantor, execute all other documents and do all other acts reasonably requested by Grantor to relinquish and effect the release of such rights to Grantor; and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of Administrative Agent's rights under the Credit Agreement with respect to the Trademark Collateral.

THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
