RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, JPMorgan Chase Bank, N.A., in its capacity as administrative agent for the Lenders (the "Administrative Agent"), was granted, pursuant to the (i) Third Amended and Restated Pledge and Security Agreement, dated as of October 26, 2015, among RESOURCE PRO LLC, a Delaware limited liability company (the "Grantor"), the other grantors party thereto from time to time and the Administrative Agent (the "Security Agreement"), (ii) Trademark Security Agreement, dated as of July 3, 2013, among Grantor and Administrative Agent, recorded with the Assignment Recordation Branch of the U.S. Patent and Trademark Office on July 3, 2013 at Reel/Frame 5063/0967 ("2013 Trademark Security Agreement") and (iii) Trademark Security Agreement, dated October 26, 2015, among Grantor, the other grantors party thereto from time to time and Administrative Agent, recorded with the Assignment Recordation Branch of the U.S. Patent and Trademark Office on October 27, 2015 at Reel/Frame 5653/0396 ("2015 Trademark Security Agreement", together with the Security Agreement and the 2013 Trademark Security Agreement, the "Security Agreements"), a continuing first priority security interest in all of Grantor's right, title, and interest in, to and under the Trademark Collateral (as defined in the Security Agreements), including without limitation the registrations and applications listed in Schedule A hereto.

WHEREAS, in connection with the sale of the Grantor, the Administrative Agent has agreed to terminate and release its security interest in the Trademark Collateral of Grantor, and to irrevocably reassign, retransfer and reconvey to Grantor any right, title and interest of the Administrative Agent in, to and under the Trademark Collateral of Grantor, in each case as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases and terminates its security interest in the Trademark Collateral, including those listed on Schedule A hereto, and irrevocably reassigns, retransfers and reconveys to Grantor any right, title and interest of the Administrative Agent in, to and under the Trademark Collateral of Grantor.

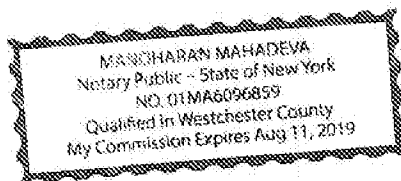
