## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE SECURITY INTEREST IN TRADEMARKS (“**Release**”) is made and effective as of April 13, 2018 and granted by The Bank of New York Mellon Trust Company, N.A. (as successor to BNY Financial Corporation) (the “**Collateral Agent**”), as collateral agent for the secured parties under the Security Agreement referred to below (the “**Secured Parties**”), in favor of GTRC Services, Inc., a Delaware corporation (“**GTRC**”), and Musician’s Friend, Inc., a Delaware corporation (“**Musician’s Friend**” and together with GTRC, the “**Grantors**”) and their successors, assigns and legal representatives.

WHEREAS, pursuant to the Security Agreement, dated May 25, 1995, among the Collateral Agent and the Grantors (the “**Security Agreement**”), each Grantor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a security interest in and to all of the right, title and interest of such Grantor in, to and under the Trademark Collateral (as defined below);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office at Reel 1411, Frame 0815 on November 13, 1995; and

WHEREAS, the Grantors have requested that the Collateral Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantors of any and all right, title and interest the Collateral Agent and the Secured Parties may have in the Trademark Collateral pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby states as follows:

1. Release of Security Interest. Collateral Agent, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreements in any and all right, title and interest of the Grantors, and reassigns to the Grantors any and all right, title and interest that it may have, in, to and under the following (collectively, the “**Trademark Collateral**”):

(a) any and all trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered, including the trademark registrations and applications set forth in the Schedule attached hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof (“**Trademarks**”);

(b) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the Trademarks; and

(c) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
