RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is given as of June 20, 2018 to Horizon Hobby, LLC, a Delaware limited liability company (the "Company"), by CIBC BANK USA, formerly known as The PrivateBank and Trust Company (in its individual capacity "CIBC"), as administrative agent ("Administrative Agent") for certain lenders.

WHEREAS, Company, and certain of its affiliates ("Grantors") and Administrative Agent entered into an Intellectual Property Security Agreement dated May 26, 2017, which was recorded in the United States Patent and Trademark Office on June 5, 2017 at Reel 6076, Frame 0628 (the "Security Agreement") pursuant to which Grantors granted to Administrative Agent a security interest in certain trademarks, including, without limitation, Company's grant to Administrative Agent of a security interest in the trademarks identified on Exhibit A to this Release (such trademarks identified on Exhibit A hereto are the "Released Trademarks"); and

WHEREAS, Grantors have requested that Administrative Agent release its security interest in and liens upon the Released Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby releases its lien on and security interest in the Released Trademarks and reassigns any and all interest it may have in the Released Trademarks to Company. The foregoing release shall not be deemed a release of any other trademarks collaterally assigned by Company or any of its affiliates to CIBC or Administrative Agent, whether under the Security Agreement or otherwise.
