Assignor hereby covenants and warrants that, with respect to the Trademark, Assignor has the full right to convey the above-prescribed rights, title, interest and goodwill by this Assignment, free of any encumbrances. Assignor further covenants and warrants that no other agreement has been or will be executed in conflict with this Assignment.

Assignor agrees to perform all affirmative acts that may be necessary or desirable to perfect the above-described transfer of rights, at Assignee's expense, as well as to cooperate with Assignee in obtaining and/or providing information required in any proceedings relating to the Trademark, at Assignee's expense.

This Assignment shall be binding upon and inure to the benefit of the respective successors and assigns to each of the parties.
