RELEASE OF SECURITY INTEREST IN
TRADEMARKS dated as of June 21, 2018 (this “Release”), by
JPMORGAN CHASE BANK, N.A. (“JPMCB”), as the
administrative agent (the “Administrative Agent”) and collateral
agent (the “Collateral Agent”).

A. Reference is made to (i) the Amended and Restated First Lien Credit Agreement, dated as of August 20, 2013, as amended and restated as of July 9, 2014 and as further amended by the Incremental Facility Amendment, dated as of July 29, 2016 (and as otherwise amended, restated, supplemented or modified prior to the date hereof, the “Credit Agreement”), among TriNet HR III, Inc. (f/k/a TriNet HR Corporation), a California Corporation (the “Borrower”), TriNet Group, Inc., a Delaware Corporation (“Holdings”), the lenders from time to time party thereto and JPMCB as Administrative Agent, (ii) the Amended and Restated First Lien Guarantee and Collateral Agreement dated as of August 20, 2013, as amended and restated as of July 9, 2014 (and as amended, restated, supplemented or modified prior to the date hereof, the “Collateral Agreement”), among the Borrower, Holdings, the Subsidiary Loan Parties from time to time party thereto and JPMCB, as Administrative Agent and Collateral Agent, (iii) the Notice of Grant of Security Interest in Trademarks dated as of August 20, 2013, among the Borrower and the Collateral Agent, (iv) the Notice of Grant of Security Interest in Trademarks dated as of August 20, 2013, among Holdings and the Collateral Agent, (v) the Notice of Grant of Security Interest in Trademarks dated as of August 20, 2013, among Accord Human Resources, Inc., an Oklahoma Corporation and the Collateral Agent, (vi) the Notice of Grant of Security Interest in Trademarks dated as of August 20, 2013, among Ambrose Employer Group, LLC, a New York limited liability company and the Collateral Agent and (vii) the Notice of Grant of Security Interest in Trademarks dated as of August 20, 2013, among the Borrower and the Collateral Agent (the documents set forth in clauses (iii) through (vii), the “Trademark Security Agreements”, and together with the Collateral Agreement, the “Security Agreements”).

B. Pursuant to the Security Agreements, the Borrower, Holdings, Accord Human Resources and Ambrose Employer Group, LLC (in such capacity, the “Grantors”) granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title and interest of the Grantors in, among other things, the Trademarks set forth on Schedule I hereto (the “Trademark Collateral”), and pursuant to the Trademark Security Agreements, such security interest was recorded with the United States Patent & Trademark Office (the “USPTO”) on January 21, 2014 at Reel/Frame 5197/0422, on January 21, 2014 at Reel/Frame 5197/0430, on August 20, 2013 at Reel Frame 5094/0485, on August 20, 2013 at Reel Frame 5094/0479 and on August 20, 2013 at Reel Frame 5094/0458.

C. Pursuant to the Payoff Letter dated as of June 21, 2018, among the Borrower and the Administrative Agent, the Administrative Agent agreed to release any and all liens and security interests it may have in the Trademark Collateral pursuant to the Security Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledge, the Collateral Agent, on behalf of the Secured Parties, does hereby state as follows:

SECTION 1. Terms. Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Trademark Security Agreements, the Credit Agreement, or the Collateral Agreement, as applicable.

SECTION 2. Release. The Collateral Agent, on behalf of itself, the Secured Parties and their permitted successors and assigns, does hereby terminate the Trademark Security Agreements and, release, relinquish and discharge its and their lien and security interest granted under the Security Agreements in the Trademark Collateral and any right, title or interest granted under the Security Agreements it has in the Trademark Collateral shall hereby cease and become void. This Release is made without representation or warranty by, or recourse to, the Collateral Agent, or any other Secured Party.

SECTION 3. Further Assurances. The Collateral Agent hereby authorizes the Grantor or the Grantor's authorized representative to record this Release with the USPTO. The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect and record the release of the security interest contemplated hereby, solely at the Borrower's cost.

AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
