RELEASE OF SECURITY INTEREST IN PATENTS, COPYRIGHTS AND TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN PATENTS, COPYRIGHTS AND TRADEMARKS (the "Release"), dated as of June 21, 2018, is executed by STERLING NATIONAL BANK, a national banking association ("Secured Party"), in favor of the grantors identified on the signature pages hereto (whether one or more, each together with its successors and permitted assigns, a "Grantor" and collectively, the "Grantors").

Recitals

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of March 31, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), by and among each Grantor and Secured Party, the Secured Party agreed to extend credit to the Grantors upon the terms and subject to the conditions set forth therein. All capitalized terms used in this Release which are not defined herein shall have the same meanings given such terms in the Loan Agreement or the Intellectual Property Security Agreement (hereinafter defined), as applicable;

WHEREAS, pursuant to the terms and conditions of the Loan Agreement, Secured Party holds a lien against the intellectual property rights owned by each Grantor;

WHEREAS, pursuant to the terms and conditions of that certain Patent, Copyright and Trademark Security Agreement, dated as of March 31, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Intellectual Property Security Agreement"), among the Grantors and Secured Party, as security for the payment or performance, as the case may be, in full of the Secured Obligations, each Grantor granted to the Secured Party, its successors and assigns, a security interest in all right, title and interest in, to and under any and all of the Intellectual Property Collateral, then owned or thereafter acquired by each Grantor or in, to or under which each Grantor then had or at any time thereafter may have acquired any right, title or interest, including, without limitation, the Patents, Copyrights and Trademarks identified on Schedule 1 attached hereto (collectively, the "Intellectual Property Security Interest").

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on April 3, 2017, at Reel/Frame 6029/0712;

WHEREAS, pursuant to the terms and conditions of that certain payoff letter, dated as of the date hereof, by and among Secured Party, National Entertainment Network, LLC and the other Credit Parties party thereto, Secured Party has consented to, among other things, the release and termination of the Intellectual Property Security Interest, including, without limitation, termination of the liens on all Intellectual Property Collateral identified on Schedule 1 attached hereto; and

WHEREAS, the Grantors have requested and Secured Party has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge in full of the Intellectual Property Security Interest and the reassignment to each applicable Grantor of any and all right, title and interest that the Secured Party may have in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby covenants and agrees as follows:

Secured Party hereby (i) terminates the Intellectual Property Security Agreement; (ii) relinquishes, discharges, and releases in full the Intellectual Property Security Interest, including under

the Intellectual Property Security Agreement and the Loan Agreement; and (iii) reassigns to each applicable Grantor any and all such right, title and interest that it may have in the applicable Intellectual Property Collateral of such Grantor (including, without limitation, all Intellectual Property Collateral identified on Schedule 1 attached hereto).

Secured Party hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively evidence, record and carry out the purposes of this Release, all at the expense of the Grantors. Secured Party authorizes the Grantors (or their designees) to file such documentation as is necessary to effect the releases of the Intellectual Property Security Interest and requests that the United States Patent and Trademark Office and any applicable government officer note and record the release hereby given and any other filings necessary to evidence the release and termination of Secured Party's rights under the Intellectual Property Security Agreement and the Loan Agreement, with respect to the Intellectual Property Security Interest.






