## TRADE MARK ASSIGNMENT

THIS ASSIGNMENT is made the 4 day of June 2018

### PARTIES

- (1) **Spotify Limited**, a company incorporated in England and Wales under company number 6436047, whose registered office is at 4<sup>th</sup> Floor, 25 Argyll Street, London, W1F 7TU, England (the "Assignor").
- (2) **Spotify AB**, a limited company incorporated under the laws of Sweden, with registered office at Regeringsgatan 19, 111 53 Stockholm, Sweden and registered with the Sweden Trade and Companies Register under number 556703-7485 (the "Assignee").

### BACKGROUND

- (A) The Assignor is the proprietor of the following trade mark application and registrations (the "Trade Marks"):

- (B) The Assignor has agreed to assign the Trade Marks to the Assignee on the terms set out in this agreement.

### AGREED TERMS

#### 1. ASSIGNMENT

In consideration of the sum of £1 paid by the Assignee to the Assignor (the sufficiency and receipt of which the Assignor hereby acknowledges), the Assignor hereby assigns to the Assignee with full title guarantee and free from all encumbrances, the Trade Marks and all and any rights in and to the Trade Marks including any common law rights and all the goodwill attaching to the Trade Marks.

#### 2. PROCEEDINGS

- 2.1 This assignment shall include the right for the Assignee to bring proceedings against any third party in respect of the Trade Marks (including proceedings against any third party for infringement of the Trade Marks or for passing off or for otherwise infringing the rights of the Assignor in the Trade Marks) and whether such infringement took place prior to or after the date of this agreement.
- 2.2 The Assignor agrees and undertakes to provide the Assignee (at its request) with all such assistance with any proceedings which may be brought by or against the Assignee, against or by any third party, in relation to the Trade Marks.

#### 3. FURTHER ASSURANCE

The Assignor agrees to promptly give any and all further assistance as the Assignee may reasonably request if this is required in order to give full effect to this assignment and to vest in the Assignee the full benefit of the rights assigned above.


#### 1. GOVERNING LAW AND JURISDICTION
