Trademark Assignment Agreement

This Trademark Assignment Agreement (the "Agreement") is entered into this 27th day of March, 2018 (the "Effective Date") by and between JOB Coffee Company, LLC, a Florida limited liability company with a notice address of 340 Corporate Way, Suite 300, Orange Park, Florida 32073 ("Assignor") and Redleaf Organic Coffee, LLC, a Washington limited liability company with a notice address of 209 W Main Street, Suite 102, Kelso, Washington 98626 ("Assignee").

WHEREAS, Assignor owns the rights, title, and interest in and to that certain application for the trademark *Redleaf Fresh Roasted*, Serial Number 86943900 (the "Mark"); and

WHEREAS, Assignor and Assignee entered into that certain Settlement Agreement of even date herewith (the "Settlement Agreement") pursuant to which Assignor agreed to assign to Assignee all of its rights, title and interest in and to the Mark.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged by Assignor, the parties agree as follows:


1. Assignor hereby conveys and assigns to Assignee, and Assignee hereby accepts from Assignor, all of Assignor's right, title, and interest in and to the Mark.
2. Assignor represents and warrants that:
  - a. Assignor owns the entire right, title, and interest in and to the Mark.
  - b. The application for the Mark is valid.
  - c. With the exception of the license disclosed in the Settlement Agreement to Agincourt Industries, LLC d/b/a Maple Street Biscuit Company and its subsidiaries, affiliates and franchisees (collectively "Maple Street"), Assignor has not otherwise licensed the Mark to any other person or entity.
  - d. Execution of this Agreement and performance of the Assignor's obligations hereunder shall not violate or conflict with any other agreements to which Assignor is a part or provision of Assignor's Operating Agreement.
3. Upon execution of this Agreement, Assignee shall pay to Assignor the Assignment Fee as set forth in the Settlement Agreement.


