RELEASE OF INTELLECUTAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (the "Release") is made on this 30 day of April, 2018 by Regions Bank, in its capacity as administrative agent for a group of lenders (in such capacity, the "Administrative Agent").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of November 10, 2016 (the "TSA"), by Alphalyties LLC, a Pennsylvania limited liability company ("Grantor"), Grantor granted to the Administrative Agent a security interest in certain Trademark Collateral (as defined therein). Capitalized terms used herein but not otherwise defined shall have the meaning given such terms in the TSA;

WHEREAS, the security interest granted to the Administrative Agent under the TSA was recorded at the United States Patent and Trademark Office on November 11, 2016, at Reel 5918 and Frame 0550; and

WHEREAS, the Administrative Agent has agreed to terminate and release all of its interest in and to all of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates and releases all mortgages, liens, security interests and any other rights that are or may have been granted to the Administrative Agent in and to the Trademark Collateral, including without limitation, any Trademarks identified on Exhibit A.
