TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement, effective October 31, 2017 (the "*Effective Date*"), is entered into by and between CA Acquisition, LLC, an Illinois limited liability company d/b/a Chicago Aerosol ("*Assignor*"), and Nakoma Products LLC, an Illinois limited liability company ("*Assignee*").

WHEREAS, Assignor own all rights, title and interest in the trademarks identified in the attached Schedule with respect to the jurisdictions identified therein (collectively, the "*Marks*");

WHEREAS, pursuant to that certain Contribution Agreement executed by the parties on October 31, 2017, Assignee desires to acquire all rights and interest in the Marks and that part of the goodwill of Assignor's business connected with the use of and symbolized by the Marks, and Assignor is willing to assign to Assignee all rights and interest in the Marks and that part of the goodwill of Assignor's business connected with the use of and symbolized by the Marks; and

WHEREAS, in order to effectuate Assignor's assignment of the all rights and interest in the Marks and that part of the goodwill of Assignor's business connected with the use of and symbolized by the Marks, the parties are executing this instrument of assignment.

NOW, THEREFORE, for the consideration set forth in the Contribution Agreement, the receipt and adequacy of which is hereby acknowledged, Assignor agrees as follows:

1. The recitals stated above are hereby incorporated herein and shall have binding and interpretive effect.

2. Assignor does hereby assign, convey and transfer to Assignee, its successors, assigns and legal representatives, the full and entire right and interest in and to the following property:

- (i) the Marks;
- (ii) that part of the goodwill of Assignor's business connected with the use of and symbolized by the Marks;
- (iii) all of the trademark rights in the Marks under the applicable laws of any jurisdiction, including all rights granted under 15 U.S.C. §1051, *et. seq.* (collectively, the "*Trademark Rights*");
- (iv) the right to claim the Trademark Rights and to obtain registrations therefor in the sole name of Assignee under the applicable trademark laws of any jurisdiction; and
- (v) all causes of action for, and claims for damages by reason of, any infringement of the Trademark Rights, which causes of action and claims arose prior to the date of execution hereof.

3. Assignor further agrees that, at the request of Assignee and without charge or cost to Assignor, it will: (i) execute and have executed any and all other documents of any kind whatsoever, and provide whatever information may be required, to carry out the terms and intent of this Trademark Assignment Agreement; and (ii) fully cooperate with Assignee, as reasonably required, to enable Assignee to duly record this instrument of assignment with trademark offices in all applicable jurisdictions, so that Assignee's ownership of the Trademark Rights in the Marks is duly made of record.
