This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (the "Release") is dated as of April 26, 2018 by BNP PARIBAS, as Administrative Agent (the "Administrative Agent") in favor of AAHC ACQUISITION, LLC, DYK AUTOMOTIVE, LLC, FTL ACQUISITION, LLC, PAW ACQUISITION, LLC, IE ACQUISITION, LLC, and SERVICE CHAMP, INC. (each, a "Grantor" and collectively, the "Grantors").

WITNESSETH

WHEREAS, the Grantors, Highline Aftermarket Acquisition, LLC ("Company"), and the Administrative Agent entered into that certain Security Agreement dated as of March 17, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered to the Administrative Agent that certain (i) Grant of Trademark Security Interest dated as of March 17, 2017 (the "Trademark Security Agreement") and recorded with the United States Patent and Trademark Office on March 17, 2017 at Reel/Frame Nos. 6011/0503, 6011/0073, 6011/0088, 6011/0583, 6011/0103, and 6011/0118 and (ii) Grant of Copyright Security Interest dated as of March 17, 2017 (the "Copyright Security Agreement") and submitted to the United States Copyright Office on May 25, 2017 for recordation, pursuant to which the Grantors granted to the Administrative Agent a security interest in all right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement) and Copyright Collateral (as defined in the Copyright Security Agreement);

WHEREAS, the Grantors have requested that the Administrative Agent release its security interest in all right, title and interest in and to the Trademark Collateral and Copyright Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title or interest in or to any and all of its Trademark Collateral and Copyright Collateral, including the trademark registrations, trademark applications, and copyright registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral and Copyright Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral and Copyright Collateral under the Security Agreement, Trademark Security Agreement, and Copyright Security Agreement.
