AMENDED AND RESTATED  
CERTIFICATE OF INCORPORATION  
OF  
FIDELIS SENIORCARE, INC.

(Pursuant to Sections 242 and 245 of the  
General Corporation Law of the State of Delaware)

Fidelis SeniorCare, Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "General Corporation Law"),

DOES HEREBY CERTIFY:

1. That the name of this corporation is Fidelis SeniorCare, Inc. and that this corporation was originally incorporated pursuant to the General Corporation Law on November 12, 2004 under such same name.

2. That the corporation amended its certificate of incorporation on July 6, 2005, August 1, 2006, amended and restated its certificate of incorporation on October 31, 2007, October 31, 2008, further amended its certificate of incorporation by a Certificate of Amendment filed on April 25, 2012, again amended and restated its certificate of incorporation on September 14, 2012, and further amended its certificate of incorporation by Certificates of Amendment dated January 22, 2013, January 23, 2013, June 28, 2013, November 21, 2013, December 26, 2013 and again amended and restated its certificate of incorporation on July 30, 2014.

3. That the corporation's board of directors duly adopted resolutions proposing to amend and restate the Certificate of Incorporation of this corporation, declaring said amendment and restatement to be advisable and in the best interests of this corporation and its stockholders, and authorizing the appropriate officers of this corporation to solicit the consent of the stockholders therefor, which resolution setting forth the proposed amendment and restatement is as follows:

**RESOLVED**, that the certificate of incorporation of this corporation be amended and restated in its entirety to read as follows:

**FIRST:** The name of this corporation is Concerto Healthcare, Inc. (the "Corporation").

**SECOND:** The address of the registered office of the Corporation in the State of Delaware is 615 S. Dupont Hwy, in the city of Dover, County of Kent, Delaware 19901. The name of its registered agent at such address is National Corporate Research, Ltd.

**THIRD:** The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law.
