This Assignment is given pursuant to the Agreement for Sale and Purchase of Assets dated June 20, 2001 among Goodrich Corporation, Sumitomo Bakelite co., Ltd and Erie Research LLC and is subject to the terms thereof, and shall not be construed to limit, alter, impair, enhance or enlarge the rights and obligations of Assignee and Assignor thereunder and is given solely for purposes of separately evidencing the transactions contemplated thereby.
