**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of June 19, 2018, by TPG SPECIALITY LENDING, INC., in its capacity as Collateral Agent. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Longview US Holdings, Inc., a Delaware corporation (“Grantor”) and Collateral Agent are parties to that certain Trademark Security Agreement dated as of June 30, 2014 (the “Security Agreement”) pursuant to which Grantor granted a security interest to Collateral Agent in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Collateral Agent, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 27, 2015, at Reel 5486, Frame 0506;

WHEREAS, Grantor has requested that Collateral Agent release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby releases its Lien on and security interest in, all of Grantor’s right, title and interest in, to and under the following (collectively the “Trademark Collateral”):


- (i) all of its Trademarks listed on the attached Schedule 1;
- (ii) all goodwill of the business symbolized by the Trademarks and the applications and registrations thereof;
- (iii) all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof; and
- (iv) all damages arising from past, present and future violations thereof.

2. Collateral Agent hereby releases, grants and conveys to the Grantor, without any representation, recourse or undertaking by Collateral Agent, any and all Collateral Agent’s right, title and interest in and to the Trademarks and the Trademark Collateral.
