RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Faxitron Bioptics, LLC, a Delaware limited liability company with offices at 3440 East Britannia Drive, Suite 150 , Tucson, AZ 85706 ("Grantor"), granted a security interest in and lien upon certain trademarks and related rights to New Spring Mezzanine Capital, L.P., a Delaware limited partnership ("Lender") as set forth in the Intellectual Property Security Agreement, dated July 18, 2011 by Grantor in favor of Lender (the "Security Agreement");

1. that on June 21, 2018, ("Release Date") it released and reassigned to Grantor any and all liens, security interests, right, title and interest of Lender pursuant to the Security Agreement in the trademarks more fully identified in Schedule A, together with the goodwill of the business symbolized thereby, without recourse or presentation or warranty, express or implied, of any kind;
2. that as of the Release Date any power of attorney or similar rights granted by Grantor to Lender pursuant to or in connection with the Security Agreement; and
3. that it authorizes and requests that the United States Patent and Trademark Office notes and records the existence of this Release of Security Interest in Trademarks.
