Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned hereby certifies the following information relating to the merger of Lindblad Expeditions, Inc., a New York corporation, with and into Argo Expeditions, LLC, a Delaware limited liability company, as of this 8<sup>th</sup> day of July, 2015:

FIRST: The name of the surviving limited liability company is Argo Expeditions, LLC, a Delaware limited liability company (the "Surviving LLC").

SECOND: The name of the foreign corporation being merged into the Surviving LLC is Lindblad Expeditions, Inc. The jurisdiction in which the foreign corporation was formed is the State of New York.
