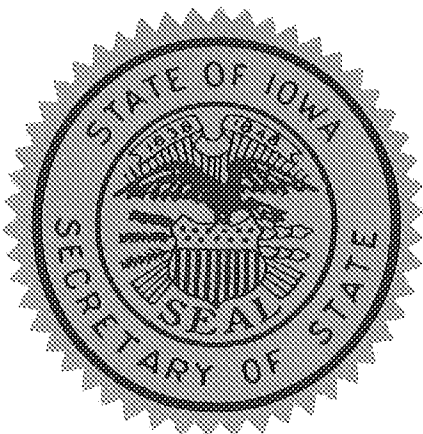

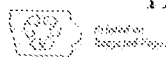

TO THE SECRETARY OF STATE  
OF THE STATE OF IOWA:

Pursuant to Section 490.1113 of the Iowa Code, the undersigned hereby adopts and submits the following Articles of Conversion:

1. Prior to the Effective Date (as defined below) **Diamond V Mills, Incorporated** was an Iowa corporation (the "Corporation").
2. On the Effective Date (as defined below) the Corporation shall be converted to **Diamond V Mills, LLC**, an Iowa limited liability company (the "Company"), which shall be governed under the Revised Uniform Limited Liability Company Act, Chapter 489 of the Iowa Code.
3. The date on which the conversion of the Corporation into the Company shall become effective under the governing statute of the Company is the date on which the Certificate of Organization of the Company becomes effective (the "Effective Date").
4. The Certificate of Organization of the Company, filed with the Iowa Secretary of State on the same date as these Articles of Conversion, shall become effective on December 31, 2017 at 11:59 p.m., unless a statement of cancellation is filed with the Iowa Secretary of State prior to such time.
5. The conversion was duly approved and authorized as required by Chapter 490 of the Iowa Code.
6. The conversion was duly approved and authorized as required by Chapter 489 of the Iowa Code and all documents required by Chapter 489 of the Iowa Code to be filed with the Iowa Secretary of State to effectuate the conversion have been filed concurrently with these Articles of Conversion.
