## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of June 21, 2018 by **SILICON VALLEY BANK**, in its capacity as Administrative Agent (the “*Assignee*”) in favor of **ADRYLAN COMMUNICATIONS, LLC (f/k/a ADRYLAN COMMUNICATIONS, INC.)**, a Delaware limited liability company (“*Grantor*”).

**WHEREAS**, the Grantor executed and delivered a Trademark Security Agreement, dated as of May 23, 2016 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Agreement*”), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on May 24, 2016, at Reel 5799, Frame 0691;

**WHEREAS**, Grantor has requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks (as defined in the Agreement) (collectively, the “*Trademark Collateral*”) as herein provided; and

**WHEREAS**, Grantor has requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee’s security interests in and liens on the Trademark Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


1. terminates the Agreement and releases, terminates and discharges all liens and security interests in Grantor’s right, title and interest in, to and under the Trademark Collateral, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

**THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.**
