## TRADEMARK ASSIGNMENT

**THIS ASSIGNMENT** is made as of the <sup>25<sup>th</sup></sup> day of June, 2018, by Assignment America, LLC, a Delaware Limited Liability Company with an address of 6551 Park of Commerce Boulevard, Boca Raton, Florida 33487 (“Assignor”) on the one hand, and Cross Country Talent Acquisition Group, L.L.C., an Oklahoma Limited Liability Company with an address of 5201 Congress Avenue, Suite 100, Boca Raton, FL 33487 (“Assignee”) on the other hand.

WHEREAS, Assignor owns a United States trademark registration for INTELIST AF TRAVEL, Registration Number 3,479,298 covering “recruiting healthcare professionals including nurses and allied health professionals for long-term employment contracts at hospitals and other healthcare facilities” in Class 35 (the “Trademark Registration”);

WHEREAS Assignee is acquiring all of Assignor’s right, title, and interest in the Trademark Registration, as well as all goodwill associated with (a) the Trademark Registration and (b) INTELISTAF TRAVEL trademark when used in connection with the services covered by the Trademark Registration (the Trademark Registration and all goodwill, collectively, the “Trademark”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby assigns, transfers and delivers, free and clear of all liens, encumbrances and claims, to the Assignee, and Assignee hereby accepts, all right, title, and interest in, to, and under the Trademark, and in and to all causes of action, either in law or in equity for past, present, or future infringement or other violations thereof, and any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing and in and to all rights corresponding to the foregoing.
2. Assignor agrees to promptly execute all documents and assist in all proceedings to perfect, register, and record the rights of the Assignee to the Trademark as Assignee may reasonably deem appropriate, and any additional documents that are reasonably necessary to accomplish the intent of this Trademark Assignment. If Assignor does not within ten (10) business days of presentment return the requested executed documents, then Assignee is hereby granted a limited power of attorney to execute all such documents on Assignor’s behalf. This power of attorney is coupled with an interest and is irrevocable.
