RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of June 28, 2018 ("Effective Date") by VTR Lonestar, LLC (the "Administrative Agent"), in favor of LHP Operations Co., LLC ("Grantor"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement or the Trademark Security Agreement (as defined below), as applicable.

WHEREAS, Grantor, the Administrative Agent, and the other parties thereto entered into that certain Security Agreement dated as of March 13, 2017 (as the same may be amended, modified, extended or restated from time to time, the "Security Agreement"), which required the parties to enter into the Trademark Security Agreement (defined below);

WHEREAS, Grantor and the Administrative Agent entered into that certain Notice of Grant of Security Interest in Trademarks (the "Trademark Security Agreement"), under which Grantor granted to the Administrative Agent a continuing security interest in and continuing lien upon, the trademarks and trademark applications set forth on Schedule 1 attached hereto (the "Trademark Collateral");


