## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of June 28, 2018 (the “Effective Date”), is made by Bank of America, N.A., in its capacity as Administrative Agent (the “Administrative Agent”), in favor of the grantor parties identified on the signature page hereto (collectively, the “Grantors”, and, each individually a “Grantor”).

WHEREAS, pursuant to that certain ABL Security Agreement, dated as of August 4, 2015, by and among the Administrative Agent, the Grantors and certain other parties thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “ABL Security Agreement”), the Grantors granted to the Administrative Agent, in its capacity as Administrative Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the ABL Security Agreement, certain Grantors executed and delivered a Notice of Grant of Security Interest in Trademarks, dated as of August 4, 2015 (the “2015 Agreement”) and certain Grantors executed and delivered a Notice of Grant of Security Interest in Trademarks, dated as of March 1, 2018 (together with the 2015 Agreement, the “ABL Trademark Security Agreements”), in each case, for recordal with the United States Patent and Trademark Office;

WHEREAS, the ABL Trademark Security Agreements were recorded with the United States Patent and Trademark Office at the locations listed on Annex A hereto;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the ABL Security Agreement or the ABL Trademark Security Agreements, as applicable.
2. Release. The Administrative Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth Schedule I attached hereto, arising under the ABL Security Agreement and the ABL Trademark Security Agreements. If and to the extent that the Administrative Agent has acquired any right, title or interest in and to the Trademark Collateral under the ABL Trademark Security Agreements, the Administrative Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.
3. Termination. The Administrative Agent, without representation or warranty of any kind, terminates and cancels the ABL Trademark Security Agreements.
4. Further Assurances. The Administrative Agent agrees to take all further actions, and provide to the Grantors and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.


