RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), effective as of this 28 day of June, 2018, given by WILMINGTON TRUST, NATIONAL ASSOCIATION, as successor in interest to MSDC JC INVESTMENTS, LLC, with an address at 1100 North Market Street, Wilmington, Delaware 19890, in its capacity as agent (in such capacity, together with its successors and assigns, the "Agent") to Pacific Motor Trucking Company, a Missouri corporation ("PMTC"), Jack Cooper Transport Company, Inc., a Delaware corporation ("JCTC") and AXIS Logistic Services, Inc., a Delaware corporation ("AXIS", and together with PMTC and JCTC, the "Grantors"), with an address at 1100 Walnut Street, Suite 2400, Kansas City, Missouri 64106, as follows:

W I T N E S S E T H

WHEREAS, the Grantors and the Agent are parties to that certain Credit Agreement, dated as of March 31, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, each Grantor executed that certain Security Agreement, dated as of April 2, 2015 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement"; all initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or, if not defined therein, in the Credit Agreement), and granted to the Agent a security interest in all of such Grantor's right, title and interest in and to the following (collectively, the "Trademark Collateral") to secure the Secured Obligations (as defined in the Security Agreement):

(a) all of its Trademarks including those referred to on Schedule A, exclusive, however of (i) any Trademarks that are protectable, registered or applied for solely under the laws of jurisdictions outside the United States, and (ii) any Excluded Collateral;

(b) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(c) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark, including right to receive any damages or (ii) injury to the goodwill associated with any Trademark.

WHEREAS, in furtherance of the Security Agreement, the Grantors executed a Trademark Security Agreement, dated April 2, 2015 (the "Trademark Security Agreement"), which was recorded on April 2, 2015 with the United States Patent and Trademark Office as Reel 5490 Frame 0588;

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademark Collateral to the Grantors and to dissolve those liens and encumbrances created by the Trademark Security Agreement and the Security Agreement in respect of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby grants, assigns and conveys, without recourse or warranty, to the Grantors all of its rights, title and interest in the Trademark Collateral, and terminates, releases, discharges, quitclaims and relinquishes unto the Grantors any and all security interests and liens it has against the Trademark Collateral.

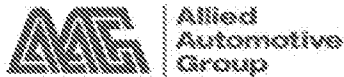
