**ARTICLES OF ORGANIZATION**

The undersigned, David Lanphar, whose post office address is Fidelity Engineering, LLC, 25 Loveton Circle, Sparks, Maryland 21152, Attn: David Lanphar, being at least 18 years of age and duly authorized to execute and file these Articles of Organization, hereby forms a limited liability company under the Maryland Limited Liability Company Act (the "Act") and certifies to the Maryland State Department of Assessments and Taxation (the "SDAT") as follows:

1. Conversion from Maryland Corporation. Pursuant to Section 3-901 of the Maryland General Corporation Law and the provisions of the Act, these Articles of Organization are being filed with the SDAT contemporaneously with Articles of Conversion converting Fidelity Engineering Corporation, a Maryland corporation (the "**Converting Corporation**"), to Fidelity Engineering, LLC, a Maryland limited liability company (the "**Company**"). Upon the completion of the conversion in accordance with the Maryland General Corporation Law and the Act, the Company shall, for all purposes of the laws of the State of Maryland, continue as the same entity as the Converting Corporation.

2. Name of the Company. The name of the Company is: Fidelity Engineering, LLC.

3. Purposes. The purposes for which the Company is formed are: (i) to conduct any lawful business as may be approved by the members of the Company in accordance with the Operating Agreement of the Company, as amended from time to time; and (ii) to do all things necessary, convenient or incidental to the foregoing.

4. Principal Office. The principal office, mailing address and place of business of the Company shall be 25 Loveton Circle, Sparks, Maryland 21152.

5. Resident Agent. The name and address of the resident agent of the Company are David Lanphar, located at Fidelity Engineering, LLC, 25 Loveton Circle, Sparks, Maryland 21152, Attn: David Lanphar. The resident agent of the Company named herein is a Maryland resident.


6. Existence. The Company shall have a perpetual existence.

7. Effective Date. These Articles of Organization shall be effective on the date these Articles are accepted by the SDAT.


8. Limitation of Authority of Members. Pursuant to Section 4A-401(a)(3) of the Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to act for the Company solely by virtue of being a member.

ARTICLES OF CONVERSION FROM A CORPORATION  
TO A LIMITED LIABILITY COMPANY**

Fidelity Engineering Corporation, a Maryland corporation (the "**Corporation**"), hereby files these articles of conversion (these "**Articles**") with the Maryland State Department of Assessments and Taxation for the purposes of converting from a corporation to a limited liability company under Section 3-901 of the Maryland General Corporation Law (the "**MGCL**") and certifies:

**FIRST:** The Corporation is a Maryland corporation formed by the filing of Articles of Incorporation with the Maryland State Department of Assessments and Taxation (the "**SDAT**") on February 3, 1947. The name under which the Corporation was originally incorporated was Fidelity Engineering Corporation. The name of the Corporation immediately prior to the filing of these Articles is Fidelity Engineering Corporation

**SECOND:** By virtue of these Articles and the Articles of Organization filed for record contemporaneously herewith, the Corporation is converting into Fidelity Engineering, LLC (the "**Company**"), a limited liability company formed under and pursuant to the Maryland Limited Liability Company Act (the "**Act**").

**THIRD:** Upon the completion of the conversion in accordance with the MGCL and the Act, the Company shall, for all purposes of the laws of the State of Maryland, continue as the same entity as the Corporation.

**FOURTH:** The name of the limited liability company into which the Corporation shall be converted is "Fidelity Engineering, LLC," which shall be organized in Maryland.

**FIFTH:** The conversion has been approved in accordance with Section 3-902 of the MGCL.

**SIXTH:** The manner and basis of converting outstanding shares of stock of the Corporation into membership interests of the Company is as follows: all outstanding shares of stock of the Corporation will be immediately converted, pro-rata, into an equal number of membership interests in the Company, which membership interests will represent 100% of the membership interests in the Company.

**SEVENTH:** The conversion is effective on the date these Articles are accepted by the SDAT.
