## TRADEMARK ASSIGNMENT

**WHEREAS**, Assignee desires to acquire the **Mark** and the above-referenced **Application**;

**WHEREAS**, Assignee and Assignor acknowledge and agree that the beneficial ownership of the **Mark** has been held by the Assignee at all times for income tax purposes pursuant to that certain Amended and Restated Management Services Agreement, entered into as of January 18, 2017, by and between the Assignee and Assignor, and accordingly, Assignee and Assignor shall disregard the Assignment contemplated by this agreement for income tax purposes;




