## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is dated as of June 29, 2018 by LBC CREDIT AGENCY SERVICES, LLC, a Delaware limited liability company, as administrative agent (hereinafter referred to as the "Agent");

### WITNESSETH:

WHEREAS, STAMPEDE MEAT, INC., a Delaware corporation (the "Grantor"), and Agent are parties to a certain Trademark Security Agreement dated June 20, 2017, between Debtor and Agent which was recorded in the United States Patent and Trademark Office on June 21, 2017 at Reel 6088, Frame 0933, as further amended by that certain Corrective Assignment dated July 6, 2017 and filed at Reel 6098, Frame 0915 (the "Trademark Security Agreement"), pursuant to which Grantor granted to Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule I attached hereto and certain other property related thereto (collectively, the "Trademark Collateral"). All capitalized terms used herein without definition shall have the same meaning herein as such terms are defined in the Trademark Security Agreement; and

WHEREAS, Grantor has requested that Agent release its security interests in the Trademark Collateral and reassign the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


Agent hereby releases its security interests in, and hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Agent, all of its right, title and interest, if any, in and to the Trademark Collateral, including the following:

- (i) all Trademarks and Trademark Intellectual Property Licenses to which Grantor is a party including those registered and applied for Trademarks referred to on Schedule I;
- (ii) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and
- (ii) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Intellectual Property License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License.
