Assignor hereby authorizes and requests the US Patent and Trademark Office, and the corresponding entities or agencies in any applicable forgoing countries, to record Assignee as the assignee and owner of the Trademark Rights and to issue all corresponding registrations to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this Assignment.
