TRADEMARK RELEASE

This **TRADEMARK RELEASE** is made as of July 2, 2018 (“Effective Date”) granted by, CITIZENS BANK, N.A., as administrative agent (in such capacity, the “Administrative Agent”), in favor of APG MEDIA OF CHESAPEAKE, LLC, a Delaware limited liability company, and APG MEDIA OF SOUTHERN MARYLAND, LLC, a Delaware limited liability company (each, a “Grantor” and, collectively, the “Grantors”).

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement (the “Trademark Security Agreement”) by, *inter alios*, the Grantors in favor of the Administrative Agent dated November 3, 2015, the Grantors granted to Administrative Agent a continuing priority security interest in and to all of such Grantor’s right, title and interest in the trademarks set forth on Schedule 1 attached hereto (collectively, the “Trademarks” or the “Trademark Collateral”);

WHEREAS, a Notice of Grant of Security Interest in Trademarks was recorded with the United States Patent and Trademark Office on November 4, 2015 at Reel 5660, Frame 0818;

WHEREAS, the Administrative Agent wishes to release and restore all right, title and interest in and to the Trademark Collateral to the applicable Grantor, including the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby (i) terminates the Trademark Security Agreement, and (ii) terminates, cancels, releases and discharges any and all security interests or liens it has against the Trademark Collateral, and all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and grants, assigns and conveys, without recourse or warranty, to the applicable Grantor all of its rights, title and interest in the Trademark Collateral. The Administrative Agent hereby authorizes the Grantors or any of their authorized representatives to file this Trademark Release with the United States Patent and Trademark Office or any other applicable governmental office and the Administrative Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer or relevant governmental authority record this Trademark Release. The Administrative Agent hereby agrees to execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by the Grantors, at the Grantors’ expense, to fully effectuate the purposes of this Trademark Release.
