## TRADEMARK ASSIGNMENT AGREEMENT


This TRADEMARK ASSIGNMENT AGREEMENT dated 4/1/18 (“Effective Date”), is made:

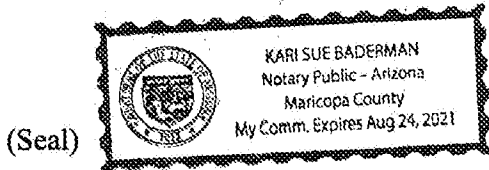

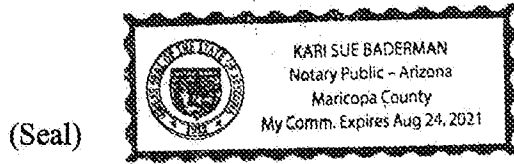
