SECOND LIEN RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Second Lien Release of Security Interest in Trademarks (“Trademark Release”) is made as of July 2, 2018, by MACQUARIE CAPITAL FUNDING LLC, a Delaware limited liability company with an address at 125 West 55th Street, NY, NY 10019, as Collateral Agent (the “Agent”) in favor of POLYCOM, INC., a Delaware corporation with an address at 6001 America Center Drive, San Jose, Colorado 95002 (the “Grantor”).

W I T N E S S E T H

WHEREAS, Grantor executed and delivered that certain Second Lien Guarantee and Collateral Agreement, dated as of September 27, 2016, in favor of the Agent for the ratable benefit of the Secured Parties (as amended, restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”);

WHEREAS, Grantor and Agent entered into a certain Grant of Security Interest in Trademarks dated September 27, 2016 (the “Second Lien Trademark Security Agreement”), notice of which recorded on September 27, 2016 at the United States Patent and Trademark Office at Reel 5885, Frame 0712, and recorded March 26, 2018 at Reel 6309, Frame 0818;

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Second Lien Trademark Security Agreement.

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Grantor pledged and granted to the Agent for the ratable benefit of the Secured Parties a continuing security interest in its Intellectual Property included in the Collateral, including the Trademarks included in the Collateral;

WHEREAS, Grantor granted the Agent, under the terms of the Second Lien Trademark Security Agreement, a continuing security interest in and Lien on all of the right, title and interest of the Grantor in all of the Trademark included in the Collateral (including, without limitation, those items listed on Schedule A) then owned or at any time thereafter acquired or created by such Grantor or in which such Grantor had at any time or in the future acquired any right, title or interest (the “Security Interest”) in favor of the Agent; and

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Agent, for itself and on behalf of the Secured Parties in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademarks of the Grantor, including the Trademarks on Schedule A, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including any goodwill associated with the use thereby.
