**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 29, 2018, is made by Wells Fargo Bank, National Association (the "Grantee").

**WHEREAS**, pursuant to those certain three Grants of Security Interests in United States Trademarks, dated as of June 5, 2014, April 21, 2016 and August 12, 2016, respectively (each an "IP Security Agreement" and collectively, the "IP Security Agreements"), by and among The Walking Company Holdings, Inc., a Delaware corporation (the "Grantor") and the Grantee, the Grantor granted a security interest to the Grantee in certain Marks including the Marks set forth on Schedule A in each IP Security Agreement; and

For the purposes of this agreement the term "Marks" shall have the meaning assigned to such term in the IP Security Agreements.

**NOW, THEREFORE**, for valuable consideration, the Grantee hereby terminates and releases all mortgages, liens, and security interests granted to the Grantee in the following:

1. all of the Grantors' Marks including those referred to on Schedule I attached hereto;
2. all goodwill of the business connected with the use of, and symbolized by, each Marks; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by any Grantor against third parties for past, present or future (i) infringement or dilution of any Mark or (ii) injury to the goodwill associated with any Mark.
